Intellectual Disability and Social Protection Policy in the Middle East and North Africa (MENA) Region (Conflict-Affected Countries):

A Proof of Concept Based on Lebanon, Tunisia and Jordan

Summary and Research Background

This project aimed to shed light on the social protection policies available to people with intellectual disabilities in conflict-impacted countries in the MENA region, namely, Jordan, Lebanon and Tunisia. This encompasses direct crises such as the recent Israel-Lebanon conflict, and it also includes the shockwaves experienced in neighbouring countries such as the influx of Syrian refugees coming into Jordan in the past decade. That, and the presence of other crises such as the Beirut blast, the COVID-19 pandemic, and the economic difficulties experienced in the region have -to varying degrees-disrupted social protection systems, disproportionately harming people with intellectual disabilities and their carers.

We sought to collect and examine the perspectives of policymakers and NGOs, and most importantly, to amplify the voices of people with intellectual disabilities themselves. Our thematic analysis revealed key themes such as 'lack of implementation of laws,' 'chaotic social protection systems,' 'structural violence resulting from prolonged crisis,' and the burden on families who are often left to take sole responsibility for care.

Key Findings

There are significant gaps in the implementation of disability laws and social protection legislation in the MENA region (Jordan, Lebanon, Tunisia). Local policies and guidance are often outdated, confusing to understand, lack enforcement, and fail to engage people with intellectual disabilities.

Bureaucratic hurdles, limited awareness, and a dominant medical model of disability hinder access to care, education, and employment leaving families to take on the burden of care and face financial strain and social stigma. Political and economic instability, the Covid-19 pandemic and rising tensions have exacerbated these challenges. That said, domestic and international organizations play important roles in filling these gaps. Some of these efforts are being translated into current national social protection reforms such as the introduction of Social Grants in Lebanon that aim to provide cash transfer support to people with disabilities (see https://www.unicef.org/lebanon/national-disability-allowance).

Policy Recommendations

The study calls for legal and governance reforms to align national laws with the Convention on the Rights of Persons with Disabilities, including updating Lebanon's Law 220 to adopt rights-based language, enforcing Tunisia's employment quotas or better still, developing a more integrative employment approach that includes people with disabilities, including people with intellectual disabilities especially in the private sector, and extending Jordan's Disability Law to include refugees













with intellectual disabilities. It emphasizes the need for independent monitoring and oversight bodies with representation from people with intellectual disabilities and their caregivers to ensure policy implementation.

Additionally, the study recommends crisis preparedness measures, such as prioritizing access to humanitarian aid for people with intellectual disabilities and integrating intellectual disability-inclusive criteria into donor funding. Finally, regional collaboration through a MENA taskforce is proposed to share best practices and improve systemic support across the region.
